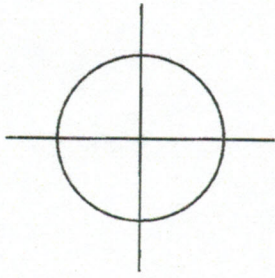

The map displays the industrial area of Calgary, Alberta. Key features include:

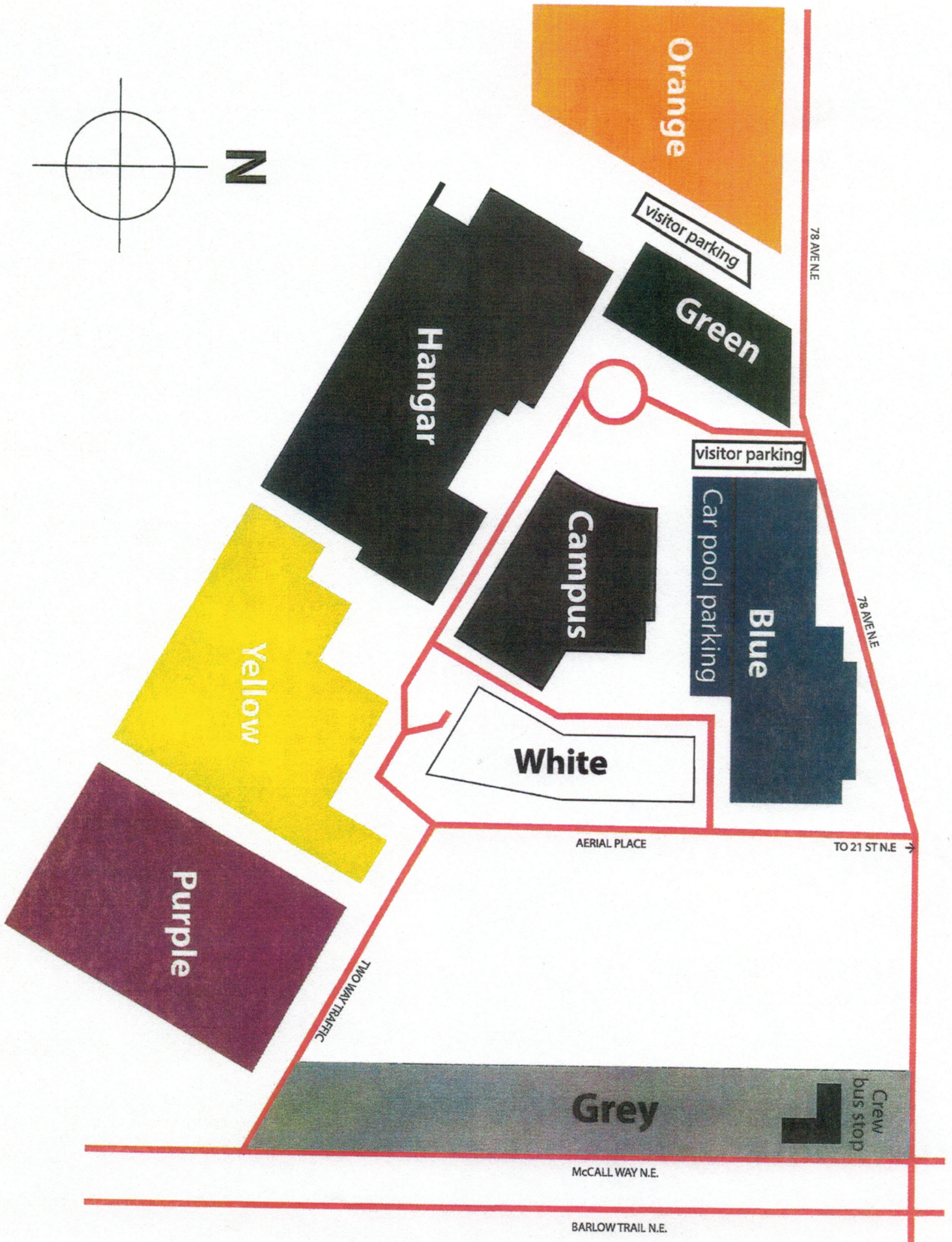
- Streets:** Beckwith Blvd, Centre St, 64 Ave, McKnight Blvd, and the Bow River.
